One of our objectives at Kindred Life is to support our clients in their efforts to further their education. Nationally, fewer than 2% of teen moms complete college by age 30. Our clients are beating that statistic.

A Lake County client, Carla, had been working hard on her academic objectives with the support of her College of Lake County academic advisor, Emily Ciesil. Having overcome many personal obstacles, Carla dreams of becoming a Special Education Teacher. In one of their meetings, Carla shared about the encouragement and support she receives through Kindred Life. Impressed by the ministry and its work, Emily started a fundraising campaign for Kindred Life on Facebook for her birthday!



Soon thereafter, our counselors started to sense that more of our clients desired to continue their education but felt there were too many obstacles for them to move forward. Emily visited a Life Education Group Night to encourage clients in their next steps and help them to understand their options. Working with their mentor, each client set a next step goal and earned a special night out at Texas Roadhouse.

As Emily began to work with clients, it was clear! She had instantly become part of the family.
